ORDER :

During the discussions in the Legislative Assembly on the L.A.Bill 17 of 2002 (Andhra Pradesh Farmers Management of Irrigation Systems (Amendment) Bill, 2002) on 17.03.2003 the Hon'ble members requested for ensuring representation in the Water Users Associations for the customary users like Fishermen, People engaged in making Pottery and Washer Men etc., by way of co-option of representatives of these users. As per Section 2 (1) (x) of Andhra Pradesh Farmers Management of Irrigation Systems Act, 1997, "Water User" means and includes any individual or body corporate or a society using water for Agriculture, Domestic, Power, Non-domestic, Commercial, Industrial or any other purpose from a Government or the corporation source of Irrigation. As per sub section 4(1), (ii) of section (3) of the Andhra Pradesh Farmers Management of Irrigation Systems Act all other water users who are co-opted as members constitute the general body of the Water Users Association.

2. In the reference 2nd read above, under rule 9(3), it is ordered that the District Collector shall prepare or cause to prepare a list of all other water users in form "C" which shall include the land holders or the tenants on the basis of record of rights in a non-notified area to be co-opted as members.

3. After careful examination of the above issue, it is ordered that the District Collectors co-opt such of the members having customary rights like Fishermen, People engaged in making Pottery, Washer Men etc., who are dependent on the water source for their livelihood into the respective Water Users Associations and prepare or cause to prepare the list of all other water users in form "C".
